Please understand that our public forums are not structured as question and answer sessions, but rather they are offered as opportunities to share your thoughts with the Board. Any Board responses to public comment will be addressed during Board Forum, or during committee reports.

There are times when a member of the public makes a comment or asks a question about an employee. New Jersey statute does not permit us to discuss personnel issues in public. Also as a matter of law, a Board of Education may only vote for or against the hiring of an employee upon the recommendation of the superintendent. WHEREAS, the Board has determined to issue Refunding School Bonds (the "Refunding School Bonds") to refund the \$9,830,000 aggregate principal amount of the outstanding 2006 Refunding School Bonds maturing on or after July 15, 2017 (the "Refunded Bonds"); and

WHEREAS, in addition to the use of the proceeds of the Refunding School Bonds towards the payment of principal of and interest on the Refunded Bonds, and in accordance with N.J.A.C. 6A23A-14.1(h)7, the Board seeks to utilize Capital Reserve Funds in an amount not to exceed \$1,000,000 to pay a portion of the principal of and interest on the Refunded Bonds; and

WHEREAS, the Board now seeks to authorize the transfer of an amount not to exceed \$1,000,000 to the Debt Service Fund to be applied to the payment of a portion of the principal of and interest on the Refunded Bonds.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE BOARD OF EDUCATION OF THE TOWNSHIP OF BERNARDS IN THE COUNTY OF SOMERSET, NEW JERSEY AS FOLLOWS:

- 1. An amount not to exceed \$1,000,000 is hereby authorized and directed to be transferred from the Capital Reserve Fund to the Debt Service Fund to be applied to the payment of a portion of the principal of and interest on the Refunded Bonds.

XIV. Board Forum

1) PARCC Testing

Board Attorney John Croot discussed PARCC. He noted that by law PARCC is still the official testing method and that the Board of Education has an ethical obligation to uphold laws in the State of New Jersey. He acknowledged that PARCC brings about organizational stresses such as the preparation for the test and the disruptions to the school schedule. Mr. Croot clarified that there are no "opt-out" provisions in the law however the District made test refusal as painless of a process as possible for parents and students.

Matthew Hall, the Supervisor of Science & Technology, explained why some students who were refusing PARCC testing had to log into the testing platform.

Superintendent Nick Markarian clarified a previous statement regarding possible negative consequences for the district if there is a low response to PARCC testing. He also stated concerns that students taking the test were not doing so to their full potential.
