# VII. Student Representative – Gordon Li

Mr. Li wished everyone a Happy Pi Day. Mr. Li spoke about the outstanding successes of the Ridge Dance Team, the Ridge Swim Team, Ridge Ice Hockey and Ridge Forensics and outlined various placements and awards that had been earned by these teams and clubs. Mr. Li discussed the upcoming Senior Prom and events that occurred during Pi Day designed to benefit the community.

### VIII. Board President Comments

President McKeon discussed the upcoming Town Hall meeting that will be held and noted that the Board is working toward setting up Bernards Connect meetings again that had previously stopped during the public health emergency.

### IX. Board Presentation

1) **Post Secondary Report** – Sean Siet, Assistant Superintendent, and Kristin Fox, Assistant Superintendent of Curriculum & Instruction

Assistant Superintendent Fox and Assistant Superintendent Siet provided the Bernards Township School District Post-Secondary Report for the Class of 2021 as Mr. Siet and Ms. Fox are the current acting Co-Directors of Guidance for the 2021-22 School Year.

Topics addressed in the SAT/ ACT presentation by Assistant Superintendent Siet were as follows:

- SAT and ACT Status, number of students who participated in testing, average scores and the test optional status
- SAT vs. ACT including test contents, timing, including significant changes, guessing penalties, scoring and updates
- SAT Benchmark scores for course areas and mean scores during the past four years in comparison with the State of New Jersey and nationally and also a comparison between Ridge High School and other select high schools in New Jersey
- ACT mean scores during the past five years both for Ridge High School and the State of New Jersey, ACT benchmark scores, percent of students meeting college readiness benchmarks during the past six years and scores between comparison districts
- An overview of the Method Test Prep 2.0, a program to assist students with preparing for SAT and ACT testing

Assistant Superintendent Fox discussed Advance Placement (AP) exam scores. Items addressed were:

- An overview of advanced placement courses and exams
- The impact of the public health emergency on AP exams and modifications made during the Spring of 2021 and the exam schedule that was instituted as a result
- Student participation rates during the past six years, increases and decreases in course testing students participated in and the percentage of students enrolled in a course participating in the corresponding exam
- A five year score summary for AP testing, a breakdown of passing scores during the past five years, an AP equity and excellence analysis for 10th, 11th and 12th graders and a breakdown of scores by subject matter.

Assistant Superintendent Siet discussed college admissions for the class of 2021 including matriculation data by type during the past six years and the top four states in which students matriculated.

Assistant Superintendent Fox discussed class profiles noting that all metrics increased from the class of 2020 to the class of 2021. Metrics included the average GPA, PSAT,

SAT and ACT scores, class application trends and the top ten colleges attended for the class of 2021.

Assistant Superintendent Siet discussed college comparisons and percentage of Ridge High School applicants accepted including a breakdown of Ivy League College acceptance rates vs. applications received. Mr. Siet discussed current trends in college admissions. Mr. Siet provided a graphic that provided a visual representation of where the class of 2021 attended.

Board members questioned and discussed what could be done to capture the numbers of students who move from one school to another after the first year of post-secondary enrollment, asked about student application and selection rates for Ivy League schools, a board member suggested that the focus adjust to the fact that a high percentage of students are going to to highly competitive schools and discussed other methods of post-secondary education such as technical school.

Ms. Light discussed Technology and proposed that the Board of Education create a Technology Committee to assist in guiding the district and assist the community with the Technological needs. Board members discussed various ways that technology is currently addressed during the various committee meetings and the nature of the commitment the Board Members currently have in committees.

Board members discussed post secondary attendance, the merits of tracking Ivy League School admissions and how to determine if students remain with their choices after the first year or what changes are made.
