Several educators from the district were invited by Superintendent Nick Markarian to discuss their recent achievements.

Daniel Zugale, Ridge High School Band Director, discussed two awards that have been recently given to the high school. **WHEREAS**, the Bernards Township Board of Education has heavily invested time and funds into the acquisition and integration of Apple products in local operations that will be wasted if non-Apple products were used to supplement the existing technology; and

**WHEREAS**, the use of non-Apple products would require either the wholesale replacement of the technology currently used by the Bernards Township Board of Education or an unsupportable level of training, support and maintenance services that would utterly defeat the purpose of the public contracting laws;

**NOW, THEREFORE, BE IT RESOLVED** that the Bernards Township Board of Education hereby authorizes the purchase of proprietary Apple technology products approved under the HCESC contract.
