Superintendent Markarian commented on the retirement of Athletic Director, Rich Schello. Mr. Markarian recognized Mr. Shello's service to the district and noted he would be further recognized at the June meeting as done annually.

XIV. **BT Connect Meeting:** District Reserves, Debt and Capital Projects - Planning for the Future

Board Members: Robin McKeon, Tim Salmon and Karen Gray

President McKeon introduced the BT Connect Meeting topic and outlined the goals for the meeting that included a high level overview of issues, considerations for long term planning and to collect input through the community discussion. Ms. McKeon provided information for state aid and funding and trends over the last decade and provided information for extraordinary aid funded for special education students. Ms. McKeon discussed the 2% cap on the budget and the impact on the district.

Ms. Gray discussed trends in the student population, construction projects from 1994-2007 noting that no money has been borrowed for construction projects since 2005 and the logistics of the debt levy.

Vice President Salmon discussed district reserves and their limits along with the current district reserve funding including the emergency, maintenance and capital reserves and their balances. Mr. Salmon discussed the long range facilities plan including the plans to add on to the Ridge High School cafeteria.

President McKeon discussed the function of the strategic plan and BT Connect meeting in comparison to where the district currently is in regard to reserves, COVID relief, a new long term capital plan, demographic forecasting and potential challenges.

Vice President Salmon provided an outline of expectations for discussion groups and the input the Board of Education is looking for in consideration of the General Operating Budget and Capital Projects and Maintenance.

Attendees broke into groups to discuss balancing needs with saving for the future for the Bernards Township School District.

### XV. Public Comment

Comments from the public made through the BT Connect Meeting discussion included the following items:

- Updating high school science labs
- Parking lot, fencing, walkway and exterior lighting maintenance and improvements, add parking
- Enhance school safety and security, parking lot speed bumps, better door and access control
- Adding air conditioning in cafeterias, auditoriums and gyms
- Improving athletic fields at Ridge and Annin
- Improving stormwater management/drainage
- Providing for more seating at lunch for Ridge and Annin, challenges of unit lunch at Ridge
- Work order processing for day to day repairs and maintenance, emphasis on HVAC/climate control, pest control, having more stock on hand to expedite timeliness of repairs
- Maintain appropriate class size and a focus on academic courses and electives
- Add counseling staff emphasis on elementary schools and college admissions
- Provide tax relief without compromising rankings (e.g. prioritize teacher salaries over administrators)
- Solicit community members to help, Veterans Association for bus drivers and substitute teaching staff
- Difficulty in finding staff, staff shortages, especially teachers, retaining staff, teacher salaries
- Parity for boys and girls athletic team facilities
- Management of district debt
- School start times
- Additional paved access points to Ridge campus
- Renovate Ridge Locker Room and add air conditioning to it
- Repave area in front of Ridge wellness center
- Renovate Ridge snack shack
- Address bathroom vandalism
- Provide more food options for people with food allergies
- Improve Lee Field sound system
- Expand instructional coaching program and ESS staff
- Improve the lighting in the RHS main gym
