In instances where the Board feels that there is a misunderstanding or inaccuracy, a member of the Board or Administration will address it in the Board Response portion of the agenda.

There are times when a member of the public makes a comment or asks a question about an employee. New Jersey statute does not permit us to discuss personnel issues in public. Also as a matter of law, a Board of Education may only vote for or against the hiring of an employee upon the recommendation of the superintendent. If the superintendent does not recommend a person, that person's name is not listed on the agenda and there is no vote on that action. If it is necessary for the Board to go into executive session at the end of the meeting,

we will provide an estimated length of time for the session and whether any action is anticipated to be taken upon returning to public session.

X. Superintendent’s Report

Prior to the introduction of the 2008 Ridge Forensics Team and the 2008 Division A Ice Hockey State Champions, Dr. Goger congratulated 7th and 8th grade French students who participated in the National French Contest sponsored by the American Association of Teachers of French. This contest is open to French students nationwide. A 7th grade student received the top score in New Jersey placing second in the nation and two other students scored in the top 10 in New Jersey. Eleven 8th grade students scored in the top 10 in New Jersey, ranging from second to eight place and nationally these students ranked from third to eighth place. The scoring system for this competition is based on the number of correct answers.

1) Acknowledge **2008 Ridge Forensics Team**

Advisor David Yastremski spoke on the schedule of tournaments the team maintains during the school year and presented an explanation of this activity. He thanked the Board of Education, the administration of both the high school and Board office for their continued support and encouragement. Each national and state champion was introduced and presented with a certificate.

Director of Athletics Richard Shello commented on the success of the 2008 Ice Hockey Team, having begun as a parent funded program only 13 years ago. This year's team completed their season having 24 wins, 4 losses and 2 ties. Mr. Shello and Ridge High School Principal Frank Howlett introduced and presented each student with a certificate.
