Assistant Superintendent Siet discussed how the district plans to follow up on the audit including discussion with the students and how to reach them effectively and create a safe space for students to feel comfortable.

Ms. White mentioned that finding a way to bring the four elementary schools together more often could be an effective way to intermingle students.

Ms. Schafer thanked WAMS for hosting the November 14, 2022 Board Meeting.

President McKeon brought up the topic of board email use. Board members discussed how to effectively enforce policies.
